Meeting Minutes November 7, 2023 – 4:00 pm BOARD OF REGISTRARS MEETING

The meeting convened at 4:00 pm, Tuesday, November 7, 2023, by Chair Verde who opened the meeting via the Zoom videoconference platform, at the Community Center, and further announced that the hearings would take place from 4:00 pm to 8:00 pm over the next consecutive days. These hearings were scheduled following Mr. Raphael Richter's written complaints regarding the Truro voting registry status of 66 individuals.

Chair Verde read aloud the process for these hearings as well as housekeeping rules for those in attendance. Chair Verde noted that there would be no public comment this evening and this meeting was not being livestreamed. Chair Verde stated that all documentation (also referred to as "exhibits") were provided to the complainant, the respondent, Town Counsel, and each member of the Board of Registrars). Any other exhibits introduced this evening by either the complainant or the respondent would be added to that specific hearing file.

Scheduling of Hearings:

Chair Verde stated that unless otherwise requested by a respondent, the hearings would be heard in order of the summons number and continue through Thursday of this week. More information is posted on the Town website.

Public Disclosure:

Prior to the commencement of the public hearings, Chair Verde made a public disclosure that she was not related to Mr. Richter as there were rumors in Truro that suggested otherwise. Chair Verde said that her parents (surname of Richter) were from Sweden and that she had not used the Richter name in 22 years.

Update on Challenge Voter Hearing Process:

Town Counsel Goldberg provided legal opinions on the following highlighted topics from yesterday's hearings: the Board of Registrars' summons regarding Schedule A are indeed enforceable; Lay v. City of Lowell regarding excise tax documentation for consideration; and the standard if a respondent does not appear at a hearing may result in a negative inference but it cannot be the only consideration to remove a respondent from the voter rolls.

Town Counsel Goldberg suggested that moving forward that Attorney Bettinelli and Attorney Brewer's objections to Schedule A of the summons be noted in the record for all of the respondents whom they represent and Mr. Richter's response that none of the respondents represented by Attorney Bettinelli or Attorney Brewer provided the documents requested within the summons.

Attorney Bettinelli stated that moving forward that his and Attorney Brewer's objections regarding Schedule A will apply in all of the proceedings and will not bring up that objection in each individual hearing.

Hearings:

Rose Bayani – Chair Verde announced Ms. Bayani's name and invited Ms. Bayani to come forward. There was no reply.

Chair Verde stated that the summons which were delivered to the respondent in this matter were posted on the Town website.

Chair Verde invited Mr. Richter to present his evidence and Chair Verde noted that Mr. Richter was still under the oath he swore to yesterday.

Mr. Richter presented his evidence and Town Counsel Goldberg reminded Members to review any submitted documents and any new information. Town Counsel Goldberg also noted as Ms. Bayani was not present and should the Board of Registrars vote to strike Ms. Bayani from the Truro Registry of Voters this evening, Ms. Bayani may appeal to reopen the hearing before the next Town Meeting for good cause.

Chair Verde and the Members reviewed the evidence and then, under advice of Town Counsel Goldberg, determined what evidence were facts before considering a motion.

Chair Verde made a motion that the objector had provided sufficient evidence to strike Rose Bayani from the Truro Registry of Voters.

Vice Chair Sturdy seconded the motion.

By a vote of all in favor, 3-0-0, motion carries.

Peter Weiss – Chair Verde announced that the respondent was no longer registered to vote in Truro so there would be no hearing.

Tobin Gerhart – Chair Verde announced that the respondent had contacted her and requested that the

hearing be scheduled on November 9, 2023. There were no objections.


