Public Comment

Ms. Violeta Villamil (sp?) stated she was in attendance at the recommendation of the Town Manager. She lives next to the Congregational Cemetery and wished to lodge a nuisance complaint that dog walkers in the cemeteries were allowing their dogs to enter her yard, that some of her trees have died as a result of the dogs. She said cemetery visitors don't respect her property. Ms. Villamil stated that ten years ago someone from Wellfleet flew their plane that landed on her roof. Now she keeps an eye on it, said she has seen people doing lewd acts in the

Congregational Cemetery. States it has been affecting her physically and mentally. The commission said they were sorry for her difficulties and suggested that when she notices illegal activities in the cemetery or on the road that she contact the police. The commission noted that dog walking is allowed in cemeteries and the Town leash law applies and if she notices an offleash dog, she should report it to the police non-emergency line. Mrs. Gardner told Ms. Villamil that the commission manages the cemeteries but is not responsible for enforcing local or state law in the cemeteries, which are Town property. The commission does its best to encourage respectful behavior among cemetery visitors and will continue to do so.
