Board of Registrars Meeting Minutes May 14, 2024 – 4:00 pm

Chair Verde convened the meeting at 4:00 pm, Tuesday, May 14, 2024 held at the Town Hall.

Chair Verde reviewed the processes for this meeting and reviewed the packet of materials.
