4. Administrator's Reports

- **4.1 Superintendent's Report:** Mr. Gradone and Mrs. Costigan are working on an updated job description for Mrs. Costigan to better reflect her actual duties. The title change recommendation will be Director of Student Services and will include projects to assist the Superintendent. A complete job description will be available at the next TSC meeting. The Town is in negotiations to buy the Walsh property and there is an article on the April 30 warrant. TCS boiler conversion is a separate article on the warrant. Mr. Gradone reported September PreK had peak enrollment figures. All family requests for 4 year olds will be accommodated, not all family requests for 3 year olds will be available. 21 Truro families have requested PreK for 2019 2020. DPW would like the storage container located at TCS, they will fix it and move it to the Harbormaster. The town has contracted with an Access Co. to report on accessibility issues with town buildings. The Access Co. contractors spent 2 and 1/2 days at TCS going over the building and the grounds. The boiler conversion bids will be opened May 2, 2019.
- **4.2 Principal's Report:** Mr. Beaudet reported the 6th grade trip to Puerto Rico was phenomenal, a true educational, cultural, linguistic, diverse cultural experience. The 6th grade students put together a video of the highlights and experiences that inspired them personally. The team extends their deep appreciation to TSC for funding the trip.
- **4.3 Director of Special Education Report:** Mrs. Costigan reported April 3 professional development was spent completing the second round of DESSA. Mrs. Costigan attended a meeting at NRHS and TCS students are doing well. NRHS faculty does a great job.
